THE POLICY COUNCIL, in exercise of the powers conferred on it by sections 49 and 54 of the Criminal Justice (Proceeds of Crime) (Bailiwick of Guernsey) Law, 1999^a hereby makes the following Regulations -

Amendment of regulation 5.

1. In regulation 5(1)(d) of the Principal Regulations, for "3(1)(c)" substitute "3(2)(a)".

Interpretation.

2. (1) In these Regulations "**the Principal Regulations**" means the Criminal Justice (Proceeds of Crime) (Financial Services Businesses) (Bailiwick of

Guernsey) Regulations, 2007^b.

(2) The Interpretation (Guernsey) Law, 1948^c applies to the interpretation of these Regulations.

(3) Any reference in these Regulations to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.


Citation.
