THE COMMITTEE FOR ECONOMIC DEVELOPMENT, in exercise of the powers conferred on it by sections 3(1)(b), 9(1), 15(1)(b) and 19 of the Company Securities (Insider Dealing) (Bailiwick of Guernsey) Law, 1996<sup>a</sup>, hereby makes the following order:-

# Amendment of section 10 of the 1996 Order.

1. In section 10 of the 1996 Order for the words -

# "Channel Islands Regulated Markets

(a) the Channel Islands Securities Exchange Authority Limited;"

substitute the words -

(a) The International Stock Exchange Authority Limited (Guernsey company registration number 57527);".

#### Amendment of Schedule to 1996 Order.

2. In the Schedule to the 1996 Order for the words "Channel Islands Securities Exchange Authority Limited" substitute the words "The International Stock Exchange Authority Limited (Guernsey company registration number 57527)".

#### Revocation.

3. The Insider Dealing (Securities and Regulated Markets) (Amendment)
Order, 2015<sup>b</sup> is revoked.

# Interpretation.

- **4.** (1) In this Order " **the 1996 Order**" means the Insider Dealing (Securities and Regulated Markets) Order, 1996, as amended<sup>c</sup>.

- (3) Any reference in this Order to an enactment is a reference thereto as from time to time amended, re-enacted (with or without modification), extended or applied.
