# The Criminal Justice (Proceeds of Crime) (Legal Professionals, Accountants and Estate Agents) (Bailiwick of Guernsey) (Amendment) (No. 2) Regulations, 2013

THE POLICY COUNCIL, in exercise of the powers conferred upon it by sections 49A and 54 of the Criminal Justice (Proceeds of Crime) (Bailiwick of Guernsey) Law, 1999<sup>a</sup>, hereby makes the following Regulations:-

### Amendment of regulation 5.

1. In regulation 5(1)(c) of the Principal Regulations, for "3(1)(c)" substitute "3(2)(a)".

### Interpretation.

2. (1) In these Regulations, "the Principal Regulations" means the

## Citation.

3. These Regulations may be cited as the Criminal Justice (Proceeds of Crime) (Legal Professionals, Accountants and Estate Agents) (Bailiwick of Guernsey) (Amendment) (No. 2) Regulations, 2013.

### Commencement.

**4.** These Regulations shall come into force on the 22<sup>nd</sup> April, 2013.
