## Countries and territories that are identified by relevant external sources as presenting a higher risk of ML, TF and/or PF

Appendix I lists countries and territories that are identified by the UK, US governments, intergovernmental and supranational organisations as presenting certain ML, TF and/or PF risks. Alongside these sources, information is presented reflecting assessments of a country or territory by non-governmental organisations and think tanks which firms may also find useful when they are determining the level of country risk presented by a business relationship or occasional transaction. The Commission does not accept responsibility for the findings and conclusions of these sources. The inclusion of a country or territory in Appendix I does not automatically imply that a business relationship or occasional transaction with a relevant connection to a country or territory on Appendix I is high risk, as the firm can continue to take a risk based decision on the level of overall risk within a business relationship or occasional transaction as set out in Section 3.4 of this Handbook. Please note that those countries and territories in relation to which the FATF has called for the application of countermeasures and therefore the firm must apply ECDD measures to a business relationship or occasional transaction where the customer or beneficial owner has a relevant connection with one of those countries are listed in Appendix H.
