Countries and territories that are identified by reliable and independent external sources as presenting a higher risk of ML and or FT

Appendix I to this *Handbook* lists a number of countries and territories that are identified by reliable and independent external sources as presenting a higher risk of *ML* and/or *FT*. In assessing country risk, it will be relevant to take account of the number of occasions that a particular country or territory is listed by different external sources and the rationale for those listings. Where a country or territory is identified as presenting a higher risk by four, or five or more, separate external sources, it is more prominently highlighted in the appendix. Please note that source 1 identifies those countries and territories in relation to which the *FATF* has called for the application of countermeasures and therefore the firm must apply *ECDD* measures to a *business relationship* or *occasional transaction* where the *customer* or *beneficial owner* has a *relevant connection* with one of those countries or territories.

The Commission does not accept responsibility for the findings and conclusions of these sources. In addition to these sources as well as the guidance in Chapter 3 of the *Handbook* on countries and territories risk factors, which are not exhaustive, the firm should consider other publicly available information to check whether it should treat a particular country or territory involved in a business relationship or transaction as a country or territory presenting a higher risk of *ML* and or *FT*. The firm is expected to exercise judgement in relation to how they interpret and use these sources and to reach their own conclusions on risk.
